something burning and his house was filing with smoke. He quickly located the cause of the smoke and remedied the situation. His home has several smoke detectors and none of them went off. He tested them by pushing the test button and the buttons worked. Petrick indicated that the Oregon State Fire Marshal has lots of information on their web site.
